PERSONAL

“Personal option” allows referrers to receive the referral fee directly after 90 days from the new client’s billing start date. This option provides a direct financial benefit to the referrer, allowing them to see the results of their referral in a tangible way.



CLUB SPONSORSHIP

This option allows referrers to nominate their local club to be the beneficiary of the referral fee. By choosing this option, referrers can support their community and the organizations that matter to them. The referral fee can help their nominated club fund initiatives, renovations, or any other activities that can benefit the local community.



CHARITY

This enables referrers to nominate a charity of their choice to receive the referral fee. By selecting this option, referrers can make a positive impact on the causes they care about, whether it’s supporting healthcare, education, the environment, or any other area of need. This option gives referrers the opportunity to contribute to the greater good and make a difference in the lives of those less fortunate.





REWARDS REFERRAL PROGRAM TERMS AND CONDITIONS

ONE WEEKS BILLING (MAXIMUM CAPPED AT \$5,000 PER NEW CONTRACT)

For every successful referral, the Referrer will be eligible to receive equivalent of 1 week's billing to a maximum cap of \$5,000 to be applied as per the selected method on your form.

REFERRAL QUALIFICATION

Referrals must be for regular commercial cleaning services provided by SCS Group and not for ad hoc or one-time services.

MINIMUM CONTRACT DURATION

To qualify for the referral allocation, the referred customer must sign a minimum contract for 12 consecutive months with SCS Group. The customer must remain a current client for a period of 3 months to qualify for the referral fee.

REWARD ALLOCATION

The referral has the choice to allocate the monetary compensation in one of the following ways:

CASH PAYMENT

The referrer can choose to receive the monetary compensation as a direct debit into a nominated account paid directly to them. (please complete a Statement to a Supplier form available [here](#)).

EXISTING CLIENT

The referrer will receive the equivalent of 1 week's billing for the referred new business as a credit applied against their existing account with SCS Group.

CHARITABLE DONATION

The referral may opt to donate the monetary compensation to a registered charity or nonprofit sports club of their choice. SCS Group will facilitate this donation on behalf of the referral.

REWARD DISBURSEMENT

The selected option for the referral fee will be applied after completing 90 days from the commencement of practical works at the new client's site.

MULTIPLE REFERRALS

Referrers can make multiple referrals, and the referral rewards will be cumulative, subject to the maximum cap of \$5,000 per successful individual referral.

PROGRAM CHANGES

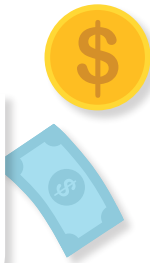
SCS Group reserves the right to modify, suspend, or terminate the Rewards Referral Program or its terms and conditions at any time without prior notice.
